Mr. Robson was also instrumental in obtaining a permanent injunction enjoining the sale of the accused instrumentality in Microsoft Word. The verdict was affirmed by both the Federal Circuit and U.S. Supreme Court.

VERSATA SOFTWARE, INC.

Represented Versata in its patent infringement litigation against SAP. After two separate trials, Versata secured a jury verdict finding that SAP infringed its patent and awarding Versata lost profits and reasonable royalty damages. Versata also obtained a permanent injunction enjoining the sale of SAP's infringing

products. The case was upheld by the Federal Circuit.

RAINDANCE COMMUNICATIONS, INC.

Represented Raindance in a patent infringement lawsuit involving numerous patents directed to voice transmission over network protocols and the recording and playback of collaborative web browsing sessions.
